2018 ACCOMPLISHMENTS

In 2018, The Arc of Larimer County worked at the local, state, and national level to remove barriers to inclusion and protect the civil rights of individuals with intellectual and developmental disabilities.

INDIVIDUAL ADVOCACY

The Arc of Larimer County provides free advocacy services for individuals with intellectual and developmental disabilities (I/DD) and their families, throughout their lifetime. This includes children and adults living with intellectual and developmental disabilities and their parents/families/guardians. The Arc of Larimer County's ultimate goal is to foster an inclusive community where people with I/DD are included in every aspect of community life.

In 2018 we provided over 2,520 hours of free advocacy services to assist people in navigating complex systems and resources.

Number of individuals served directly:

- Adults & Children: 342 (51% increase over 2017)
- One time Resource/Referral/Info: 194 (25% increase over 2017)
- Total Individuals Served in 2018: 536 (41% increase over 2017)

Main Themes addressed in 2018 through Individual Advocacy included:

- **Education** A majority of advocacy cases in 2018 were in the education system supporting families with children on individuals education plans (or IEPs).
- **Employment** Provided individuals with I/DD information on resources to find and sustain employment, including benefits counseling and co-attending meetings related to employment.
- **Housing** Supported individuals with I/DD and their families in understanding various housing options and resources, navigating housing systems, and provided direct support.
- **Court** Provided support in the court systems to individuals with I/DD and their families in areas such as restoration of competency, guardianship, testimony, assessment, and resources to inform courts.
- **Healthy Relationships** guided individuals and families towards resources for understanding boundaries to form health relationships in puberty and adulthood.
- **Child Welfare System** Supported families with children with I/DD, parents with I/DD with children in the child welfare system, and youth with I/DD who had no direct family connections.
- **Assessments and Qualification** Supported individuals thought to have I/DD in identifying resources to receive an appropriate assessment in order to access resources.
- **Social Security** Advised individuals and families during the application process or to understand benefits from the Social Security Administration.

PUBLIC AWARENESS/ OUTREACH/ EDUCATION SUMMARY

WOTZKSHOPS

Hosted 30 workshops serving 315 people

Hosted the 6th Annual Film Festival: 277 people were in attendance



TOWN HALL BIZEAKFAST

Co-Hosted The Town Hall Breakfast with Foothills Gateway and SummitStone Health Partners: over 120 people attended.



SYSTEMS ADVOCACY

SB18-145

As a result of the EFAP's annual report, Senator John Kefalas (SD14, Fort Collins) sponsored a bill mandating minimum training requirements for supported employment professionals and allocating funding for cost of the training. Additionally, SB18-145 set forth data collection requirements for state agencies to track progress towards more people with intellectual and developmental disabilities being supported in Competitive Integrated Employment.

EMPLOYMENT

About 85% of individuals with I/DD are not working not for lack of skill but lack of opportunity. The Arc of Larimer County continues to work to break down systems barriers to the employment of people with disabilities across the state.

Outreach:

In 2018, we continued our commitment to engage community partners and employers to decrease unemployment rates of people with disabilities. This work included:

 Presenting to the Northern Colorado Restaurant Association reaching 19

Employment First Advisory Partnership:

Marilee Boylan sat on the Employment First Advisory Partnership (EFAP) in 2018, followed by Cari Brown. This group was formed by legislation in 2016 with the goal of bringing Colorado into being an "Employment First State," meaning that employment would be the first and preferred option for a person with a disability. The EFAP released its first report in 2017. This document contained recommendations to law and policy makers to remove barriers to employment for people with disabilities and was updated again in 2018.

SEXUAL ASSAULT

People with intellectual disabilities are sexually assaulted at a rate that's seven times that of people without disabilities. Among women with I/DD, this jumps to twelve times that of people without disabilities. In 2018, continued collaborative relationships with SAVA (Sexual Assult Victim Advocate Center) and The Responsible Sex Education Institute to provide workshop series to teens and to young adults about healthy boundaries and relationships. We offered two, six week sessions of Healthy Bodies, Healthy Boundaries workshops. Work will continue into 2019.

GRUPO DE APOYO

Grupo De Apoyo is a support group for Spanish-speaking parents of children living with intellectual and/or developmental disabilities. 2018 Served in Larimer County: 11 Families served – 39 individual members of those families

TRANSPORTATION

Many people with disabilities rely on public transportation to get to jobs, religious services, recreational activities, and perform essential life functions. The Arc of Larimer County advocates for a transportation system in Larimer County that is accessible to all.

City Plan

In 2018, The Arc of Larimer County was awarded a Community Partner grant by The City of Fort Collins to reach out to people with disabilities to gather feedback on the City Plan Update. During late 2018 and early 2019, The Arc of Larimer County hosted 6 feedback sessions (3 open to the public and 3 for People First). The updated City Plan was adopted by City Council in early 2019. The Transit Plan, as adopted, would create a significant expansion of Transit and Paratransit Service Area for Fort Collins if fully realized.





ASSISTIVE TECHNOLOGY GRANT

Over the summer of 2018, 18 youth and adults with intellectual and developmental disabilities in Larimer County received assistive technology to help promote employment and independent living thanks to a generous grant from the Comcast NBCUniversal Foundation.



CRIMINAL JUSTICE

In 2018 outreach within the various sectors of Justice continued to be a system focus for The Arc of Larimer County.

Vital Stats:

- An estimated 85% of youth in detention centers are eligible for special education services
- 20-30% of people incarcerated in jails identify as having some degree of cognitive disability

Advocates continued to provide direct advocacy for both youth and adults that were involved in the justice system. Larimer County was able to be one of the only places in our county to provide court ordered out-patient competency restoration, helping to keep a number of youth and adults out of the juvenile detention center and prison.

In 2018, we worked with agencies in the justice domains to increase awareness of intellectual and developmental disabilities throughout various systems, including:

- Child Welfare, where our advocates supported people's teams through Permanency Round Table and Family Unity meetings.
- Coordinate and bring in experts on executive functioning and FASD for Public Defenders, District Attorney's, county courts, and adult/child protection workers
- Ongoing quarterly trainings for all Larimer County Sherriff's Office Deputies on I/DD
- Partnership with Colorado State University intern Kelly Brown in collecting data to represent understanding of I/DD in the justice system.
- Exploration of restorative justice systems to better understand and advocate for uncommon resolutions to justice issues in an effort to reduce reentry of the correctional facilities.

Larimer County is one of the few places in the country where there is a close collaboration between the corrections facility, community and community organization that specializes in I/DD are working closely together. We hope to collaborate in a way that gives both parties the opportunity to grow and learn together.



PEOPLE FIRST

People First of Larimer County is a self-directed community of adults, advised* by The Arc of Larimer County, who have intellectual and developmental disabilities.

Mission:

The mission of People First of Larimer County is to promote equity for people with disabilities to live the lives they want by fostering inclusion and self-determination in every aspect of community life.

- 2 members attended the Disability Policy Seminar in Washington DC and spoke with staff from Gardner, Bennet offices about key issues
- 2 members attended Self Advocates Becoming Empowered (SABE)

Education/Outreach

- Thanksgiving Turkey Distribution: in 2018 we provided 73 turkeys for Families in Need in Larimer County.
- Presentations given on Disability Etiquette, People First Language, and Self Advocacy
- County Clerk Angela Meyers gave members a presentation on voter rights and voting process

Advocacy

- Participated in I/DD Awareness Day at the State Capitol
- People First members gave feedback on the City of Fort Collins City Plan
- People First was represented at City of Fort Collins and Larimer County Proclamations of October as National Disability Employment Awareness Month
- Hosted the April Speaking For Ourselves Quarterly Conference at Colorado State University.
- People First members attended bill signings for the Employment First Bill and the Down Syndrome Awareness Day bill.
- Members attended Town Hall Breakfast

*Staff members in 2018 supported People First and their parent organization, Speaking for Ourselves, by proving 532 hours of support time. This time was used to facilitate meetings, arrange logistics for conferences and travel, and coordinate other needs for meetings.


